CONDITIONS FOR PARTICIPATION TO AEAJ EVENTS

FINANCIAL CONDITIONS

Two sources of funding are possible: national funding and AEAJ funding.

National funding refers to all possible sources of funding for participation to an AEAJ event provided by a court, judicial school, superior council, etc. at the national level. If you have any doubt, please check with your AEAJ national contact point if you are eligible to a source of national funding, and under which conditions.

Participants have to prioritise national funding when possible.

AEAJ funding is subsidiary, in case no national funding is available. It is provided through a lump sum from the AEAJ budget for each working group. Co-chairs are responsible of the use of this sum.

Participants have to indicate explicitly in their application if they claim for AEAJ funding. After the event, they have to claim for the reimbursement of their costs to our treasurer Ralf Höhne before the deadline indicated for each working group and provide the supporting documents, including bills and boarding passes. Covered costs include travel and accommodation for two nights.

The lump sum is equally divided between the participants who claimed for funding, in the limit of their coverable costs and up to the maximum amount of 400 euros per person. For this reason, the exact amount of the AEAJ participation can only be estimated after the event.

WG Independence and Efficiency: 30 June 2024.

WG Taxation: 31 July 2024.

WG Environmental Law: 31 October 2024.

WG Asylum and Immigration: 15 November 2024.

Please note that no AEAJ funding will be provided for participation to the General Assembly.
